

HEALTH & SAFETY POLICY STATEMENT.

Management of ELG Carbon Fibre Ltd regards the promotion of and continual improvement of Health and Safety performance and of the Health and Safety Management System as a mutual objective for management and employees at all levels. We are committed to improving our OHS performance.

ELG Carbon Fibre Ltd are committed to complying with applicable legal and with other requirements to which the organisation subscribes that relate to its OH&S hazards.

It is the declared company policy to do all that is reasonably practicable to prevent personal injury and ill health, damage to property and to protect everyone from foreseeable work hazards within the Company's control, including the public in so far as they come into contact with our activities.

It is the policy of the company, where it is reasonably practicable to:

- Provide plant, equipment and systems of work that are safe and without risk to health.
- Provide for the safe handling and transport of product, materials and equipment.
- Provide comprehensive information, instruction, training and supervision, ensuring in so far as is reasonably practicable, the Health, Safety and Welfare of every employee.
- To maintain, so far as is reasonably practicable, a safe and risk-free workplace and provide safe means of access to and egress from all workplace areas.
- Provide and maintain a safe and healthy working environment with adequate and suitable welfare facilities.
- To undertake effective risk assessments and control risks by applying the agreed hierarchy of controls.
- To consult with our workforce or appointed representative in the OHS system "decision making" process. All employees are encouraged to contribute towards making work areas as safe as possible by continually appraising working practices and ensuring that the safest possible methods are adopted.

Employees also have a duty to co-operate with this objective:

- By working safely and efficiently.
- By using any equipment provided in a safe and efficient manner.
- By reporting any incidents or near misses that have led or may lead to injury or damage.
- By adhering to safe working practices / procedures to secure a safe place of work.
- By assisting in the investigation of accidents, incidents and near misses.
- By taking a positive attitude to accident prevention, being vigilant at all times to prevent any mishaps however trivial and bringing them to the attention of the management.

ELG Carbon Fibre Ltd will comply with Health & Safety laws, regulations and other requirements relevant to our business. We will provide adequate resources and closely monitor our administration and production processes to ensure that the company's operations and opportunities are effectively managed and risks mitigated in accordance with the requirements of BS EN ISO 45001, BS EN ISO 9001, BS EN 9100, BS EN ISO 14001 & IATF 16949.

This policy will be communicated to all employees and when requested, stakeholders and or interested parties including sub-contractors that may be working on our behalf.
